**(hereinafter the "Agreement")**  
**BY SIGNING THIS DOCUMENT YOU ARE AGREEING TO ASSUME CERTAIN RISKS AND**  
**WAIVING OR GIVING UP CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE OR**  
**CLAIM COMPENSATION FOLLOWING AN INCIDENT**

***PLEASE READ CAREFULLY!***

**TO: MOORE PARK TENNIS CLUB**, and its directors, officers, employees, volunteers, coaches, pros, agents, representatives, invitees, members, independent contractors, subcontractors and their respective successors, assigns and representatives (all of whom are hereinafter collectively referred to as the "**Releasees**").

**ASSUMPTION OF RISKS**

I am aware that the novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization, and that COVID-19 is extremely contagious and is believed to spread mainly by person to person and person to surface contact. I am aware that federal and provincial governments, City of Toronto, and public health agencies have recommended social distancing and have issued orders, guidelines and recommendations to members of the public, including the prohibition of gathering in groups.

I have read and familiarized myself with the conditions of the Permit issued by City of Toronto to the Club concerning COVID-19 precautions and with the conditions issued by the Club concerning COVID-19 precautions, posted at [www.mooretennis.com](http://www.mooretennis.com), and agree to abide by all such conditions.

I am aware that playing tennis at the Club involves risk and heightened risk of contracting COVID-19. I confirm that I am aware that such risks may cause personal injury or death to me.

I FREELY ACCEPT AND FULLY ASSUME ALL SUCH RISKS, DANGERS AND HAZARDS IN ANY WAY CONNECTING TO COVID-19 AND THE POSSIBILITY OF PERSONAL INJURY OR DEATH TO ME.

**RELEASE OF LIABILITY AND WAIVER OF CLAIMS AND INDEMNITY**

In consideration of the Releasees permitting my child or children to use Club courts, for lessons and play, as Junior program members in 2020, and for other good and valuable consideration, the receipt and sufficiency of which is acknowledged, I hereby agree as follows:

1. **TO WAIVE ANY AND ALL CLAIMS** that I have or may in the future have against the **RELEASEES**, and **TO RELEASE THE RELEASEES** from any and all liability for any loss, damage, expense or injury including death that I may suffer, or that my next of kin may suffer, resulting from either my use of or my presence on the facilities and property used or permitted by the Club, **DUE TO ANY OF THE RISKS, DANGERS AND HAZARDS DESCRIBED ABOVE OR ANY OTHER RISKS, DANGERS OR HAZARDS REASONABLY ASSOCIATED WITH MY ACTIVITIES AT THE SAID FACILITIES AND**



PROPERTY. This waiver and release include any and all claims that I may have on behalf of minor children and I hereby agree to indemnify and save harmless the Releasees from any and all claims that my minor children may advance.

2. This Agreement and any rights, duties, and obligations between the parties to this Agreement shall be governed by and interpreted solely in accordance with the laws of the Province of Ontario and no other jurisdiction; and
3. Any litigation or other legal proceeding or claim involving me and the Releasees shall be brought solely within the Province of Ontario and shall be within the exclusive jurisdiction of the Courts of Ontario.
